MYTH BUSTING AND FACT CHECKING

"We've heard everybody needs to move out of their home by the time you start construction in 2028."

We plan to support all Bevin Court residents to move out by March 2026, with Roosevelt Court planned for March 2027. Churchill Court and Kennedy Court will then follow, with residents being supported to move out by March 2028. We're on track to reach these targets, however, the dates given are subject to finding suitable homes. Residents of Churchill Court and Kennedy Court may have the option to move into the new homes at Four Courts, if that's what they'd prefer. However, as it may be several years before all the new homes are ready, some residents might choose to move to a different home sooner instead.

We also want to make sure you're getting the facts – and to help tackle any misinformation that might cause unnecessary worry. If you're unsure about anything, please get in touch. We're always happy to chat and clear things up.

"You've 'cherry picked' residents to join the new Four Courts steering group."

This is untrue. The steering group is open to all residents to join. We've advertised details in your newsletter and on your dedicated web page. We have a cross section of residents from all four blocks who have expressed an interest in being part of the newly formed group. INFORMATION FOR BEVIN COURT RESIDENTS

RESIDENTS MOVE INTO NEW HOMES

Our Resettlement Team is continuing to work closely with Bevin Court residents. We can confirm three residents have now moved into their new home.

We recently held a residents' meeting on Wednesday 16 April to share updates, provide information about the ongoing works, and listen to any concerns.

If there's anything you'd like to discuss, please get in touch with your dedicated Resettlement Officer – we're here to help.

WATER MAINS WORKS

The planned works to the water mains have now been cancelled due to all residents moving out of Bevin Court by March 2026. Our contractor is still carrying out regular testing and treatment, and will continue to monitor the cold water flow.

ONGOING WORKS

We know construction work can be disruptive, and we're continuing to do everything we can to keep this to a minimum.


Cladding removal has been completed from the ground floor to the third floor, with the removal continuing from the fourth floor upwards.

There may be some dust and noise while the cladding is removed, but all work will take place between 8am and 5pm, Monday to Friday.

Hoist scaffolding has now been installed and the Haki staircase (the outside staircase to access scaffolding) is also being fitted.

To help keep everyone safe and maintain emergency access, the fenced-off parking area is being used for site containers, and the main communal car park is being used for welfare facilities.

A dedicated Resident Liaison Officer (RLO) remains based on-site if you've got any concerns, and we'll continue to hold monthly resident meetings to keep you updated. If you have any questions, please give us a call on **0800 121 60 60**. We expect work to complete by late August 2025.

FOUR COURTS ESTATE DAY

We'll be back at the Four Courts for a dedicated repairs day on **Wednesday 14 May**. Our teams will work alongside our contractors to complete as many outstanding repairs as possible.

We'll be surveying the buildings and estate to identify new communal repairs, but we encourage you to continue reporting any outstanding issues, whether inside your home or in shared areas.

In addition to repairs, we'll be providing skips for residents to dispose of unwanted items free of charge.



WE'RE SORRY FOR THE RECENT LIFT ISSUES

Our lift contractor, Jacksons, is now carrying out **weekly visits** to help spot and fix issues before they become a problem.



If a lift is out of service or develops a fault, please let us know straight away.

In an emergency – for example, if someone is stuck in a lift – press the alarm button. This will connect you directly to our lift contractors. You can also call us immediately on **0800 121 60 60**

We're sorry that some of you have experienced problems with the lift being out of service. We know how important a reliable lift is for your day-to-day life, and we're working to improve this.
